## **Personal Belongings**

There are limits to the security we can provide regarding your loved one's personal items. This is especially true for residents with cognitive challenges who often fiddle with and hide objects. For these reasons, the administrative staff would like to caution you against bringing in expensive or sentimental items. Reimbursement for lost items is decided on a case by case basis. However, generally speaking, if an item is "in custody" of the resident, you will not be reimbursed. For any further information, please see your loved one's social worker.

Questions also come up in regards to electronic devices including tablets and cloud based services such as Alexa and Echo products. Our IT or Activity departments cannot help you trouble-shoot if you or your resident are having issues using any of the devices. Also, using electronic devices to video record violates our HIPAA and privacy rules. Please reach out to your social worker or administration for any questions.
